**SUBJECT:** Request Authority to Obtain a Proposal and Negotiate a Fee with Paul J. Petretti, Civil Engineer & Land Surveyor, an SDVOB firm, in connection with Land Surveying Services at Various Locations in Northern Westchester County, New York (#21-905)

---

Authority of your Honorable Board is requested to obtain a proposal to negotiate a fee in connection with land surveying services at various locations in Northern Westchester County, New York.

The objective of this project is to provide land surveying services for various buildings, roads, and bridges in Northern Westchester County which shall include areas north of Interstate 287 up to the Putnam/Westchester County border. The land surveying services shall include, but are not limited to, topographic surveys, land feature surveys, boundary surveys, bathymetric (underwater) surveys, utility mapping, and legal property descriptions. The land surveying information will be used by Department of Public Works and Transportation, Engineering Division staff in the planning and design of various capital projects. This agreement will benefit the public as it provides land surveying information required for improvements of various County facilities in compliance with the New York State Code of Practice for Land Surveys.

On February 14, 2019, the Professional Prequalification Board was canvassed for the purpose of generating an eligible list of qualified firms to provide land surveying services for under \$100,000. The Professional Prequalification Board approved a list of seven (7) qualified firms. On September 18, 2020, the Board of Legislators approved Act No. 166-2020 which amends the rules and procedures that govern the prequalification and selection of architects, professional engineers, and land surveyors by increasing the maximum fee threshold from \$100,000 to \$250,000. As the fee for this procurement is estimated to be less than \$250,000, on January 25, 2021 the Professional Selection Board reviewed this eligible list of qualified firms and selected the best three qualified firms to possibly perform said services. The three firms were:

After careful consideration, the Professional Selection Board ranked the firm of Paul J. Petretti, Civil Engineer & Land Surveyor, an SDVOB firm, as the number one firm suitable for this proposal for these professional services. Authorization to enter into an Agreement will be submitted to your Honorable Board when negotiations are satisfactorily completed. This selection process followed the requirements as outlined in the Rules of the Professional Prequalification and Selection Boards and the Laws of Westchester County.
