RE: Request for authority to enter into an Agreement with the New York State Office for the Aging to accept a grant for an amount not to exceed \$2,517,305 to provide services under the Expanded In-Home Services for the Elderly Program, for the program period April 1, 2021 through March 31, 2022.

The County of Westchester (the "County"), acting by and through the Department of Senior Programs and Services (the "Department"), seeks authority from your Honorable Board to enter into an agreement with the New York State Office for the Aging ("NYOSFA") to accept a grant for an amount not to exceed \$2,517,305 to provide services under the Expanded In-Home Services for the Elderly Program ("EISEP"), for the program period from April 1, 2021 through March 31, 2022.

Of the \$2,517,305 in funding, 1,902,114 will be used to provide contracted homemaker, housekeeper, consumer-directed homecare, in-home contact and support - project time out, social adult day services, case management, and personal emergency response system services to frail, homebound seniors under EISEP. The remaining \$615,191 will be used by the Department to provide Direct Services and for Area Agency Administration.

The proposed agreement will serve a public purpose by providing funds that will assist the County in providing services that enable seniors to remain at home, as most seniors would prefer, thereby preventing premature institutionalization, which would come at greater expense and in a less-desirable environment.

The goals and objectives of the proposed agreement are to obtain State funds to help seniors remain in their homes in the community through the provision of quality home care services, case management, personal emergency response system services, in-home contact and support and social adult day services to provide relief and respite to their caregiver(s).

The goals and objectives of the proposed agreement are in the best interests of the County in terms of fiscal responsibility, as the proposed agreement will supply New York State ("State") funds for the services to be provided to County residents, thereby allowing the services to be provided at a reduced cost to the County. The goals and objectives of the proposed agreement are also in the best interests of the County in terms of health. The services to be provided with the grant funds will offer improved health and quality of life for the frail elderly and their caregivers by easing their burden through the provision of homemaker and housekeeper services, consumer directed home care, case management, personal emergency response system services and providing respite care through in-home contact and support and social adult day services.

The goals and objectives of the proposed agreement will be tracked and monitored by the Department's case managers through bi-monthly calls to seniors and their caregivers as to the quality of the services they are receiving and their satisfaction with the services. In addition, the Department's staff monitors and reviews case managers' client case records and records of service at the agencies providing these services, using forms approved by NYSOFA. Review of the program is done annually by a County monitor, as well as a monitor from NYSOFA.

It should be noted that the proposed grant agreement does not constitute a procurement. As such, the provisions of the Westchester County Procurement Policy do not apply.

I certify that my department, a) has copies of, or access to, all applicable laws, rules, regulations, grant applications, and grant agreements (including any master grant agreement), as well as any guidance or instructions received from the agency making the grant (the "Grant Terms"), b) has reviewed the Grant Terms, c) is aware of and understands all of the Grant Terms, and d) can and will comply with all of the Grant Terms.

Accordingly, I recommend adoption of the proposed annexed resolution.
