SUBJECT: Authority to enter into an agreement with My Sisters' Place, Inc., pursuant to which it will provide legal services as well as crisis intervention and individual counseling for victims of domestic violence at the County's Mount Vernon District Office, for a term from January 1, 2021 through December 31, 2021, for an amount not to exceed \$147,725.00.

Authority is hereby requested from your Honorable Board for the County of Westchester, acting by and through its Office for Women, (the "County") to enter into an agreement (the "Agreement") with My Sisters' Place, Inc. (the "My Sisters' Place"), pursuant to which My Sisters' Place will provide legal services as well as crisis intervention and individual counseling for victims of domestic violence at the County's Mount Vernon District Office, which is a more convenient location for those living in southern Westchester County, for a term commencing on January 1, 2021 and continuing through December 31, 2021, for an amount not to exceed One Hundred Forty-Seven Thousand Seven Hundred Twenty-Five Dollars (\$147,725.00), net of County charges, payable quarterly pursuant to an approved budget.

The County's costs and expenses will be deducted from the appropriated amount prior to quarterly payment, in accordance with Schedule A-1 attached hereto and made a part hereof.

The proposed Agreement will serve a public purpose by providing services to domestic violence victims who are residents of southern Westchester County. My Sisters' Place will provide legal services as well as crisis intervention and individual counseling for victims of domestic violence.

The goals and objectives of the proposed Agreement are to provide legal services as well as crisis intervention and individual counseling for victims of domestic violence in order to empower such individuals and to enhance the safety and security of themselves and their families.

The goals and objectives of the proposed Agreement will be tracked and monitored by the Office for Women.

Authority to exempt the proposed Agreement from the requirements of the Westchester County Procurement Policy and Procedures, pursuant to Section 3(a)(xxi) thereof, has been submitted for your Board's consideration via separate resolution.

We respectfully recommend the adoption of the attached resolution.

RESOLUTION

Upon a communication from the Westchester County Executive and the Director of the Office for Women, be it hereby

RESOLVED, that the County of Westchester, acting by and through its Office for Women, (the "County") is hereby authorized to enter into an agreement (the "Agreement") with My Sisters' Place, Inc. (the "My Sisters' Place"), pursuant to which My Sisters' Place will provide legal services as well as crisis intervention and individual counseling for victims of domestic violence at the County's Mount Vernon District Office, which is a more convenient location for those living in southern Westchester County, for a term commencing on January 1, 2021 and continuing through December 31, 2021; and be it further

RESOLVED, that in consideration for services to be rendered, My Sisters' Place will be paid an amount not to exceed One Hundred Forty-Seven Thousand Seven Hundred Twenty-Five Dollars (\$147,725.00), net of County charges, payable quarterly pursuant to an approved budget; and be it further

RESOLVED, that the County's costs and expenses will be deducted from the appropriated amount prior to quarterly payment, in accordance with Schedule A-1 attached hereto and made a part hereof; and be it further

RESOLVED, that this Agreement is subject to County appropriations; and be it further

RESOLVED, that this Agreement is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this Agreement. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this Agreement or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to My Sisters' Place, then My Sisters' Place shall have the right to terminate this Agreement upon reasonable prior written notice; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this Resolution.
