SUBJECT: Authorization to extend the term of Short Form Contract No. 20-017 with
Ramos & V Tree Services Inc. from June 21, 2021 until June 21, 2022.

Authority of your Honorable Board is requested to extend the term of Short Form Contract No. 20-017 (the "Agreement") between the County of Westchester (the "County") and Ramos & V Tree Services Inc. (the "Contractor"), 49 Midland Terrace, Yonkers, New York 10704, for the provision of all labor, material and equipment necessary for tree removal and tree trimming services at various locations along County Roads, Westchester County, New York from June 21, 2021 until June 21, 2022. The original Agreement was executed on June 22, 2020 and is for a total amount not to exceed \$20,000.00. The original Agreement completion date is June 21, 2021.

The services included in the original Agreement are in progress. The County has been satisfied with the quality of services provided to date. The services of the Contractor will be required beyond the original completion date in order to continue providing tree removal and tree trimming services at various locations along County Roads which is essential to ensure the safety of the traveling public. Attached is a Resolution requesting an extension of the Agreement from June 21, 2021 until June 21, 2022 with no increase in the not to exceed amount of \$20,000.00.

The objective of this term extension is in the County's best interest as it will prevent tree limbs and branches from falling onto County roadways.

Except as specifically amended hereby, all other terms and conditions of the Agreement will remain the same.

The Department of Public Works and Transportation will track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project. It is recognized and understood that the County shall evaluate the performance of this contract by the Consultant and shall use such evaluation in deciding to award future contracts to the Consultant.

I urge your favorable consideration of the annexed proposed Resolution.
