On March 17, 2021 the County of Westchester ("County") received and opened fifteen (15) bids for Contract No. 15-532 for Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Abbott & Price, Inc. submitted the low bid in the amount of \$4,793,317.00.

The low bidder has been investigated and it has been found that Abbott & Price, Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to upgrade the infrastructure of Tibbetts Brook Park.
