RE: Authority for the County of Westchester to enter into a Grant Agreement with the Federal Transit Administration (“FTA”) for \$12,119,000.00 in Federal Transit Capital Assistance (Grant Agreement NY-2021-007-00).

Authority is requested for the County of Westchester (the “County”) to enter into an agreement with the Federal Transit Administration (“FTA”) for \$12,119,000.00 in Federal Transit Capital Assistance. A 20% County match is required to receive the FTA funds for a total of \$3,029,750.00 broken down as follows:

Federal Funds	80%	\$12,119,000.00
Local Funds	20%	\$ 3,029,750.00
<b>Total</b>		<b>\$15,148,750.00</b>

Funds received from this grant will be utilized as follows:

**40-Foot Hybrid Bus Procurement (\$12,119,000.00 Federal)**

These funds will be used to cover the cost of purchasing hybrid 40-foot buses. Funds in the subject grant will be combined with other funds for the purpose of replacing the current fleet of 108 Orion V 40-foot buses.

The goal of this project is to maintain the Bee-Line bus fleet in a state of good repair by replacing aging buses.

The receipt of reimbursement funds will be monitored by both the Department of Public Works and Transportation and the Department of Finance.
