On March 17, 2010, five (05) bids were received and opened for Contract No. 09-539 for Manursing Lake Aquatic Habitat Restoration, Playland Park, Rye, New York.

The bids were reviewed by the Department and it was determined that Mace Contracting Corp. (MBE) submitted the low bid in the amount of \$676,900.00.

The low bidder has been investigated and it has been found that Mace Contracting Corp. (MBE):

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to comply with the Department of Environmental Conservation's Order On Consent to restore the aquatic habitat of Manursing Lake.

This contract is in the public's best interest because it will provide an environmental benefit by restoring the natural habitat of Manursing Lake, thus addressing the County Executive's priority area: Health and the Environment (HE).

If this resolution is not approved, the County will not be in compliance with the mandated Department of Environmental Conservation's Order On Consent.

The department will utilize Primavera Software Management tools to track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 09-539 be awarded to Mace Contracting Corp. (MBE) in the amount of \$676,900.00.
