RE: **Resolution authorizing the County of Westchester to enter into a permit agreement with the City School District of New Rochelle for the use of New Rochelle High School to conduct a Police Officer Examination on May 15, 2021 and May 16, 2021, in an amount not to exceed \$12,000, payable pursuant to an approved rate schedule.**

Transmitted herewith is a resolution which, if approved by your Honorable Board will authorize the County of Westchester (the "County") to enter into a permit agreement with the City School District of New Rochelle for the use of New Rochelle High School to conduct a Police Officer Examination on May 15, 2021 and May 16, 2021 at a cost not to exceed \$12,000, payable pursuant to an approved rate schedule (the "Agreement").

The Agreement will include an indemnity provision which will provide as follows:

"Westchester County does hereby covenant and agree to defend, indemnify and hold harmless the City School District of New Rochelle from and against any and all liability, loss, damages, claims, or actions (including costs and attorneys fees) of any nature or kind including those for bodily injury, to the extent permissible by law, arising out of, or in connection with the actual or proposed use of the District's property, facilities and/or activities by Westchester County."

The proposed agreement is exempt from the County's Procurement Policy and Procedures pursuant to Section 3(b) thereof, as the proposed Agreement is a license for the use of real property.

The goal of the Agreement is to provide a suitable location for the provision of a Police Officer Examination. The Department of Human Resources will monitor the Examination and the Agreement.

Accordingly, I recommend adoption of the annexed Resolution.

RESOLUTION

Upon a communication from the Commissioner of Human Resources, be it hereby

RESOLVED, that the County of Westchester (the “County”) is hereby authorized to enter into a permit agreement with the City School District of New Rochelle for the use of New Rochelle High School to conduct a Police Officer Examination on May 15, 2021 and May 16, 2021 at a cost not to exceed \$12,000, payable pursuant to an approved rate schedule (the “Agreement”); and be it further

RESOLVED, that the Agreement will include an indemnity provision which will provide as follows:

“Westchester County does hereby covenant and agree to defend, indemnify and hold harmless the City School District of New Rochelle from and against any and all liability, loss, damages, claims, or actions (including costs and attorneys fees) of any nature or kind including those for bodily injury, to the extent permissible by law, arising out of, or in connection with the actual or proposed use of the District’s property, facilities and/or activities by Westchester County.”

RESOLVED, that the County Executive or his authorized designee is hereby authorized to execute all instruments and take all actions reasonably necessary to implement this Resolution.
