SUBJECT: Authority to exercise the County's option to extend the term of an agreement with American Petroleum Equipment & Construction Company, Inc. for one two (2) year option period, thereby increasing the amount of the agreement by \$311,450.00 and extending the term of the agreement through September 30, 2023 (Contract No. 18-205)

By Resolution approved on September 13, 2018 (the "September 13th Resolution"), your Honorable Board awarded Contract No. 18-205 to American Petroleum Equipment & Construction Company, Inc. ("American Petroleum"). The September 13th Resolution authorized the County of Westchester (the "County") to enter into Contract No. 18-205 with American Petroleum, pursuant to which American Petroleum was to provide Environmental Remediation for Petroleum Based Products, Various County Facilities, Westchester County, New York for the amount of \$467,175.00 for the period of October 1, 2018 through September 30, 2021, ("Contract No. 18-205" or the "Agreement"), with the County having the sole option to extend the Agreement for one (1) two (2) year option period.

The County now seeks authority from your Honorable Board to 1) exercise the two (2) year renewal option and extend the termination date of the Agreement from September 30, 2021 to September 30, 2023; and 2) increase the amount of the Agreement by \$311,450.00 from an amount of \$467,175.00 to a new total amount not to exceed \$778,625.00.

All other terms and conditions of the September 13, 2018 Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by meeting all mandated codes and requirements in relation to fuel spills.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

Upon a communication from the Commissioner of the Department of Public Works and Transportation, be it hereby

RESOLVED, that the County is authorized to 1) exercise its two (2) year renewal option for Contract No. 18-205 with American Petroleum Equipment & Construction Company, Inc., 63 Orange Avenue, Walden, New York 12586, to provide Environmental Remediation for Petroleum Based Products, Various County Facilities, Westchester County, New York and extend the termination date of the Agreement from September 30, 2021 to September 30, 2023; and 2) increase the amount of the Agreement by \$311,450.00 from an amount of \$467,175.00 to a new amount not to exceed \$778,625.00; and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the September 13, 2018 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
