SUBJECT: Authority to exercise the County's option to extend the term of an agreement with Picco Construction LLC for one two (2) year option period, thereby increasing the amount of the agreement by \$54,170.00 and extending the term of the agreement through October 28, 2023 (Contract No. 18-208)

By Resolution approved on October 25, 2018 (the "October 25th Resolution"), your Honorable Board awarded Contract No. 18-208 to Picco Construction LLC ("Picco Construction"). The October 25th Resolution authorized the County of Westchester (the "County") to enter into Contract No. 18-208 with Picco Construction, pursuant to which Picco Construction was to provide a Service Contract for Snow and Ice Removal, 25 Moore Avenue, Mount Kisco, New York for the amount of \$81,255.00 for the period of October 29, 2018 through October 28, 2021, ("Contract No. 18-208" or the "Agreement"), with the County having the sole option to extend the Agreement for one (1) two (2) year option period.

The County now seeks authority from your Honorable Board to 1) exercise the two (2) year renewal option and extend the termination date of the Agreement from October 28, 2021 to October 28, 2023; and 2) increase the amount of the Agreement by \$54,170.00 from an amount of \$81,255.00 to a new total amount not to exceed \$135,425.00.

All other terms and conditions of the October 25, 2018 Resolution and the Agreement shall remain in full force and effect and unchanged.

This contract is in the public's best interest because it will promote the health and safety of the general public by providing safe travel ways for both pedestrian and vehicular traffic at County facilities.

As expenditures are made pursuant to this authorization, detailed records will be kept in the County's on-line financial system. These records will be easily accessible by Finance, Budget and department staff and will be reviewed regularly to ensure that funds are used appropriately.

Upon a communication from the Commissioner of the Department of Public Works and Transportation, be it hereby

RESOLVED, that the County is authorized to 1) exercise its two (2) year renewal option for Contract No. 18-208 with Picco Construction LLC, 27 Railroad Avenue, Hopewell Junction, New York 12533, to provide a Service Contract for Snow and Ice Removal, 25 Moore Avenue, Mount Kisco, New York and extend the termination date of the Agreement from October 28, 2021 to October 28, 2023; and 2) increase the amount of the Agreement by \$54,170.00 from an amount of \$81,255.00 to a new amount not to exceed \$135,425.00; and be it further

RESOLVED, that except as specifically amended hereby, all remaining terms and conditions of the October 25, 2018 Resolution and the Agreement shall remain in full force and effect and unchanged; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized to execute all documents and take all actions necessary to effectuate the purpose hereof.
