in connection with Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York

The County of Westchester ("County"), acting by and through its Department of Public Works and Transportation ("Department"), entered into Agreement Number 15-928 ("Agreement"), dated May 28, 2015, with Insite Engineering, Surveying & Landscape Architecture, P.C. ("Consultant"), 3 Garrett Place, Carmel, New York 10512, wherein the Consultant was to provide engineering design services associated with Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York. The Agreement was thereafter amended by Resolution approved August 3, 2017, for additional design services associated with Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York and to extend the completion date of the Agreement to December 31, 2021. The Agreement was thereafter amended by Resolution approved April 9, 2020, for additional design services associated with Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York and to extend the completion date of the Agreement to December 31, 2024.

The engineering services included in the original Agreement have been in progress. The Consultant has completed the construction contract documents and bid analysis. The County has been satisfied with the quality of services provided to date. A construction contract for this project was awarded to Abbott & Price, Inc. on April 15, 2021. Construction work for this project is anticipated to begin in June 2021. Construction administration services are required at this time.

Authority of your Honorable Board is therefore requested to further amend the existing Agreement between the County and the Consultant to provide for additional engineering services in connection with Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York. The Consultant shall provide construction administration services associated with this project. For construction administration services, the Consultant shall monitor the construction procedures on the site to ensure compliance with the contract documents, coordinate scheduled activities of the contractors, submit construction progress reports and review and process contractors' applications for payment.

The objective of this project will be to provide various infrastructure improvements at Tibbetts Brook Park. With the success of the pool project and the increased popularity of the park, the County is seeking to increase the in-season parking capacity at Tibbetts Brook Park. The work will include new parking facilities, resurfacing of existing park roads and walkways, drainage improvements, landscaping, site work, and playground area improvements. This Agreement will benefit the public as it will enhance this recreational facility thereby ensuring its safe use and enjoyment by the park's visitors.

The engineering discipline encompassed in this Amendment is not new, but rather, it is an integral part of the project that involves the same degree of skill, experience and complexity as the expertise generally described in the original project. Accordingly, this type of engineering discipline was originally contemplated in the Professional Prequalification Board and Professional Selection Board process.

The fee for the above services is for an amount of \$321,230.00 pursuant to an approved budget, bringing the total Agreement plus Amendments to \$538,724.00. The completion date of the Agreement shall remain December 31, 2024.

The Department will track scheduling and accomplishments by the Consultant and perform on-site inspections to ensure the successful completion of this project.

Upon communication from the Commissioner of Public Works and Transportation, be it hereby

RESOLVED, that the County of Westchester (“County”), acting by and through its Department of Public Works and Transportation (“Department”), is hereby authorized to amend Agreement No. 15-928 (“Agreement”) with Insite Engineering, Surveying & Landscape Architecture, P.C (“Consultant”), 3 Garrett Place, Carmel, New York 10512, to provide for additional engineering services in connection with Infrastructure Improvements, Tibbetts Brook Park, Yonkers, New York. The Consultant shall provide construction administration services associated with this project. For construction administration services, the Consultant shall monitor the construction procedures on the site to ensure compliance with the contract documents, coordinate scheduled activities of the contractors, submit construction progress reports and review and process contractors’ applications for payment; and be it further

RESOLVED, that for the additional services rendered, the Consultant shall be paid a fee of \$321,230.00 pursuant to an approved budget, increasing the total maximum fee to \$538,724.00; and be it further

RESOLVED, that all other provisions of the existing Agreement shall remain in full force and effect; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby authorized and empowered to execute any and all documents necessary or appropriate to effectuate the purposes hereof.
