RE: AUTHORITY TO ENTER INTO A LICENSE AGREEMENT WITH
MGE, INC., P.O. BOX 955, RIVERSIDE, CT 06878 TO OPERATE TWO
COTTON CANDY STANDS AND A POPCORN/WATER STAND AT
PLAYLAND PARK FOR THE PERIOD JUNE 1, 2021 THROUGH
SEPTEMBER 30, 2022.

Authority is requested of this Board for the County of Westchester ("County") to enter into a license agreement with MGE, Inc., P.O. Box 955, Riverside, CT 06878 to operate two cotton candy stands and a popcorn/water stand at Playland Park, Rye, New York for the period June 1, 2021 through September 30, 2022, which will cover the 2021 and 2022 operating seasons. The start and end dates for each operating season will be determined by the County.

As consideration for this license privilege, MGE, Inc. will pay the County of Westchester a license fee of \$18,000 per operating season.

The County shall have the right to: (a) terminate this agreement on thirty (30) days notice to the Licensee, or (b) assign this Agreement in its entirety to Standard Amusements LLC.

The goal and objective of this agreement is to increase County revenue while providing additional concession options for Playland patrons. This agreement promotes fiscal responsibility as the County will benefit from the additional revenue.

The objective of this agreement will be monitored using inspection and revenue reports.

The Westchester County Procurement Policy does not apply to concessions pursuant to Section 3(b) thereof, and, therefore, does not apply to this license agreement.

A Resolution is attached for your favorable consideration.

RESOLUTION

Upon a communication from the Commissioner of the Department of Parks, Recreation and Conservation, be it hereby

RESOLVED, that the County of Westchester (“County”) is authorized to enter into a license agreement with MGE, Inc., P.O. Box 955, Riverside, CT 06878 to operate two cotton candy stands and a popcorn/water stand at Playland Park, Rye, New York for the period June 1, 2021 through September 30, 2022; and be it further

RESOLVED, that for this license privilege, MGE, Inc. will pay the County of Westchester a license fee of \$18,000 per operating season; and be it further

RESOVLED, that the County shall have the right to: (a) terminate this agreement on thirty (30) days notice to MGE, Inc., or (b) assign this Agreement in its entirety to Standard Amusements LLC.; and be it further

RESOLVED, that the County Executive or his duly authorized designee is hereby empowered to execute any and all instruments and take such other actions as may reasonably be necessary to effectuate the purposes thereof.
