Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with Random Productions, LLC to authorize filming at the Michaelian Office Building, White Plains, New York on various dates from June 4, 2021 through June 17, 2021 with an estimated permit fee of \$37,375.00.**

Authority is requested for the County of Westchester, by and through its Office of Tourism & Film, to enter into a Film Permit with Random Productions, LLC to utilize locations in the Michaelian Office Building, 148 Martine Avenue, White Plains, New York to film the limited television series "The White House Plumbers" on various dates from June 4, 2021 through June 17, 2021. This request is being made because the film permit which authorizes an estimated fee of \$37,375.00 to be paid to the County, which does not include estimated overtime costs for County personnel, requires your Honorable Board's approval. This film permit will result in revenue for the County and will also promote the County and provide revenue for local businesses.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board's approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with Random Productions, LLC. is attached for your Honorable Board's approval.
