The 2021 Capital Budget contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment for milling and resurfacing of Theodore Fremd Avenue including intersection improvements at Locust Avenue. Work also includes installation of ADA curb cuts, improvements at bus stops, repair and cleaning of drainage structures and installation of new pavement markings.

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Theodore Fremd Avenue meets current codes and standards as well as reducing the County's annual maintenance costs.

The department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.
