On April 28, 2021 the County of Westchester ("County") received and opened four (4) bids for Contract No. 20-513 for Rehabilitation of Pelham Parkway (C.R. #70), from Fulton Avenue Bridge to Boston Post Road, a Total Distance of Approximately 0.30 Miles, Village of Pelham Manor, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that PCI Industries Corp. submitted the low bid in the amount of \$846,645.00.

The low bidder has been investigated and it has been found that PCI Industries Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving and to repair the substandard structural elements of the parkway.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Pelham Parkway meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 20-513 be awarded to PCI Industries Corp. in the amount of \$846,645.00.
