SUBJECT: Authority to enter into an agreement with Greyston Foundation Inc., pursuant to which the County will agree to perform certain tasks and facilitate the performance of other work, as part of grant-funded work under the Second Chance Act Comprehensive Community-Based Adult Reentry Program.

Authority is requested from your Honorable Board for the County of Westchester (the "County") to enter into an agreement (the "Agreement") with Greyston Foundation Inc. ("Greyston"), pursuant to which the County will agree to perform certain tasks and facilitate the performance of other work by Greyston, as part of the work that would be performed under the Second Chance Act Comprehensive Community-Based Adult Reentry Program if Greyston is awarded a grant for such work (the "Grant") by the United States Department of Justice (the "USDOJ").

Greyston will include the Agreement in its application to the USDOJ for the Grant. Pending an award from the USDOJ, the Agreement will be for a term from October 1, 2021 through September 30, 2024.

Under the Agreement, the County will neither receive nor expend any funds.

The proposed Agreement will serve a public purpose by helping facilitate Greyston's grant application and making provisions for the Grant-funded work that would be performed, in order to have the Grant-funded re-entry program work be performed in Westchester County.

The goal and objective of the proposed Agreement is to help facilitate Greyston's grant application and make provisions for the Grant-funded work that would be performed, in order to have the Grant-funded re-entry program work be performed in Westchester County

The goal and objective of the proposed Agreement is in the best interests of the County in terms of public safety, as helping facilitate Greyston's grant application and making provisions

for the Grant-funded work that would be performed, in order to have the Grant-funded re-entry program work be performed in Westchester County, is expected to ultimately positively affect recidivism rates.

The goals and objectives of the proposed Agreement will be tracked and monitored by the staff of the Department of Correction.

The proposed Agreement does not constitute procurement. Accordingly, the provisions of the Westchester County Procurement Policy and Procedures do not apply to the proposed Agreement.

I respectfully recommend the adoption of the attached resolution.
