On July 28, 2021 the County of Westchester ("County") received and opened ten (10) bids for Contract No. 17-519 for Site Work Improvements, Blue Mountain Reservation, Town of Cortlandt and City of Peekskill, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Laura Li Industries, LLC, a WBE firm, submitted the low bid in the amount of \$2,644,533.00.

The low bidder has been investigated and it has been found that Laura Li Industries, LLC:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to make improvements at the Blue Mountain Reservation.

This contract is in the public's best interest because it will provide for a properly maintained park which will reduce the County's annual maintenance costs.

It is my recommendation that Contract No. 17-519 be awarded to Laura Li Industries, LLC in the amount of \$2,644,533.00.
