Re: Authority to enter into an Assignment Agreement with Red Hawk Fire & Security (NY), LLC, as Assignor and ADT Commercial, LLC, as Assignee, whereby the County of Westchester ("County"), acting by and through the Westchester Community College ("WCC"), will consent to the assignment of its agreement with Red Hawk for Annual Inspection and Testing of Fire Alarm Systems at Westchester Community College for the period January 1, 2020 through December 31, 2022, to ADT.

On April 23, 2020, your Honorable Board authorized an agreement between the County, acting by and through WCC and Red Hawk Fire & Security for Annual Inspection and Testing of Fire Alarm Systems at WCC for the period from January 1, 2020 through December 31, 2022 (the "Agreement"). WCC was later informed that the proper name of that entity should have been Red Hawk Fire & Security (NY), LLC. ("Red Hawk"). The Agreement was subsequently executed.

Thereafter, WCC was informed by ADT, Inc. that it had acquired Red Hawk and merged Red Hawk into a new entity called ADT Commercial, LLC ("ADT"), effective May 31, 2020. Accordingly, authority is now requested for the County to enter into an Assignment Agreement with Red Hawk, as Assignor and ADT, as Assignee, whereby the County, acting by and through WCC, will consent to the assignment of its agreement with Red Hawk for Annual Inspection and Testing of Fire Alarm Systems at WCC for the period from January 1, 2020 through December 31, 2022, to ADT, effective upon execution of the Assignment Agreement by all parties and approval of same by the Office of the Westchester County Attorney.

All other terms and conditions of the Agreement shall remain unchanged and in full force and effect.

There will be no additional cost to WCC to enter into this transaction. An appropriate resolution is herewith attached for your consideration.
