On July 28, 2021 the County of Westchester ("County") received and opened six (6) bids for Contract No. 19-522 for Roadway Resurfacing and Additional Improvements, Theodore Fremd Avenue (C.R. #54), from 300 Feet East of North Avenue to Purchase Street, a Total Distance of 0.72 Miles, City of Rye, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Laura Li Industries, LLC, a WBE firm, submitted the low bid in the amount of \$1,451,287.00.

The low bidder has been investigated and it has been found that Laura Li Industries, LLC:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Theodore Fremd Avenue meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 19-522 be awarded to Laura Li Industries, LLC in the amount of \$1,451,287.00.
