On July 21, 2021 the County of Westchester ("County") received and opened four (4) bids for Contract No. 21-515 for Door Replacement, Volunteers of America Shelter, 25 Operations Drive, Valhalla Campus, Valhalla, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Taconic Remodeling Corp. submitted the low bid in the amount of \$101,370.00.

The low bidder has been investigated and it has been found that Taconic Remodeling Corp.:
