RE: Authorization to further Amend a Resolution approved on February 27, 2020, as previously amended, which authorized the County of Westchester to Enter into Agreements with Approved Related Services Providers, Pursuant to Section 4410, Part 200 of the New York State Education Law, in order to add an approved Related Services Provider, White Glove Community Care, Inc., effective October 1, 2021

On February 27, 2020, your Honorable Board approved a Resolution (the “February 27, 2020 Resolution”), which authorized the County of Westchester (the “County”) to enter into Agreements (the “Agreements”) with approved Related Services Providers pursuant to Section 4410, Part 200 of the New York State Education Law, for the period from July 1, 2020 through June 30, 2025, in the total aggregate amount not to exceed \$86,217,672 subject to annual County appropriations, with each provider to be reimbursed at rates established by the County and accepted by the New York State Education Department (“NYSED”) to ensure that the providers are paid at the established rates and that the County is reimbursed for state aid.

Thereafter by Resolution approved on June 25, 2020, the February 27, 2020 Resolution was amended to add one approved Related Services provider, Catherine M. Constable, to the list, in order to enter into an agreement with this provider subject to the same terms and conditions set forth in the February 27, 2020 Resolution.

Thereafter by Resolution approved on August 15, 2021, the February 27, 2020 Resolution was further amended to add another approved Related Services provider, Absolute Home Health Care, Inc., to the list, in order to enter into an agreement with this provider effective 09/01/2021 subject to the same terms and conditions set forth in the February 27, 2020 Resolution. This Resolution has not yet been approved.

Authorization is now requested to further amend the February 27, 2020 Resolution in order to add yet another approved Related Services provider, White Glove Community Care, Inc., effective 10/01/2021, to the list, in order to enter into an agreement with this provider subject to the same terms and conditions set forth in the February 27, 2020 Resolution, as amended.

This provider will serve a continued unfilled need for nursing services for preschool children with special needs in the towns/areas and their associated school districts of Westchester County that currently lack adequate provider capacity to meet the mandated Individualized Education Program requirements.

This and all agreements will promote the public health, safety and welfare of Westchester County's children with special needs by enabling their daily participation in special needs programs and other community settings that typically developing children attend. On an annual basis, approximately 3,000 children are served by the Related Services programs. In 2020, approximately 2,600 children were served.

The goals and objectives of these programs are to:

- Provide appropriate services to children from three to five years of age with developmental disabilities and/or delays in accordance with their approved Individualized Education Program (IEP).
- Provide these services in the student's least restrictive setting.

Providers will be monitored, as per their contract requirements and the Westchester County Health Department's performance measurement indicators, for the provision of services through program site visits and review of their clinical session and progress reports, and accuracy of billing by monthly reviews of submitted documentation.

Except as otherwise stated herein, all other terms and conditions of the February 27, 2020 Resolution, as amended, shall remain the same.

An appropriate resolution has been attached herewith for your Board's consideration and approval.
