SUBJECT: Authority to enter into a zero cost non-disclosure agreement with New Flyer

Incorporated related to the procurement of 40-foot electric transit buses.

(Agreement No. DOTCAP 05-21)

Authority is requested for the County of Westchester (the "County") to enter into a zero cost non-disclosure agreement with New Flyer Incorporated ("New Flyer"), related to the procurement of transit buses. The proposed agreement will be for a term of five (5) years commencing upon execution.

On January 13, 2021 the County, acting through the Bureau of Purchase and Supply, executed a purchase order to procure four (4) 40-Foot, Low Floor, Heavy Duty Electric Transit Buses and related equipment (the "Buses"). In connection with this procurement, it is necessary for New Flyer to provide the County with certain information deemed confidential by the manufacturer, including but not limited to information about its finances, costs, profits, markets, sales, customers, potential customers, employees, financial statements, manuals, formulae, data bases, computer programs, technical expertise, software, machines, inventions, research, engineering methods, practices, processes, designs, products, projects and improvements. New Flyer has requested that the County sign an agreement prohibiting disclosure of such information except if legally required.

The proposed agreement will serve a public purpose by allowing the County and New Flyer to conduct the procurement in such a way as to provide the County with exactly what it needs in terms of the new buses and related equipment.

The goal and objective of the proposed agreement is to establish the parameters to manage confidential information related to the new buses being manufactured by New Flyer.

The goal and objective of the proposed Agreement will be tracked and monitored by the staff of the Department of Public Works and Transportation.

I respectfully recommend the adoption of the attached resolution.
