The Airport Special Revenue Fund contains funds for the above referenced project.

The work under this contract consists of providing all necessary labor, material and equipment required to provide service and maintenance to the four (4) passenger jet bridges at the Westchester County Airport. This contract is for a term of three (3) years with one two (2) year renewal at the discretion of the County.

The services to be performed will benefit the general health and safety of the traveling public by maintaining the jet bridges in a safe operating condition so that the traveling public can access aircraft without using aircraft stairs from the terminal ramp and remain in ADA compliance.

The main goal of this contract will be to maintain the equipment so that it is in proper working order and safe for public use on a daily basis with limited interruption in service for mechanical repairs.

This contract will be overseen by Airport Administration, and payments will be made to the contractor only upon receipt of an invoice for performance of the scheduled maintenance services and related repairs.

Payment for this contract will be made from the Airport Special Revenue Fund, not the County General Fund and will not impact the County tax levy.

RESOLVED, that the Commissioner of Public Works and Transportation be and he hereby is authorized to solicit bids by public advertisement on the following contract:

RESOLVED, that adequate and sufficient security for the faithful performance of this contract shall be deemed to be a performance and payment bond in an amount equal to 30% of the total contract amount, and in a form approved by the County Attorney. The Bond Underwriter or Surety must appear on the U.S. Treasury's listing of approved sureties (Department Circular 570) and all Sureties must be licensed to transact business in New York as a surety company; and be it further

RESOLVED, that this advertisement for bids will state that pursuant to Chapter 308 of the Laws of the County of Westchester, the policy of the County is to encourage the meaningful and significant participation on County contracts for business enterprises owned by persons of color and women - Minority Business Enterprise (MBE) and Women Business Enterprise (WBE); and be it further
