Ster Resolution to exempt from the Westchester County Procurement Policy Re:

pursuant to Section 3(a) xxi thereof, the procurement of an Agreement with Program Design and Development, LLC for the provision of professional consulting services related to the County's application to the United States Department of Housing and Urban Development ("HUD") for the 2022

Continuum of Care for the Homeless grant.

Authority is hereby requested from your Honorable Board to exempt the procurement of an agreement with Program Design and Development, LLC from the Westchester County Procurement Policy and Procedures ("Procurement Policy") for the provision of professional consulting services involving the preparation of the County's fiscal year 2022 application to the United States Department of Housing and Urban Development ("HUD") for Continuum of Care for the Homeless grant and professional consulting services to improve the effectiveness of Westchester's system of care for the homeless and related services for the term commencing on January 1, 2022 and expiring on December 31, 2022 in the amount of \$78,000 payable pursuant to an approved budget.

This agreement will provide consulting services to the Department of Social Services which will enable the County to obtain needed HUD funding. Program Design and Development, LLC has been involved in planning and administering HUD's Continuum of Care grant programs since 1993 and is uniquely qualified to provide these services to the County. Program Design and Development, LLC has also coordinated the local HUD Continuum of Care grants for the Yonkers Housing Authority since 1995 and for the City of Mount Vernon since 1996. Based on Program Design and Development's proven past success and expertise, it would be in the

best interests of the County to exempt the proposed agreement from the requirements of Westchester County Procurement Policy.

Pursuant to Section 3 (a) (xxi) of the Procurement Policy, where this Honorable Board determines by resolution passed prior to the commencement of procurement that compliance with the Procurement Policy would not be in the best interests of the County, the requirements of the Procurement Policy may be waived. A resolution to enter into an agreement with Program Design and Development, LLC is being submitted separately with even date.
