On January 12, 2022 the County of Westchester ("County") received and opened six (6) bids for Contract No. 15-526 for Replacement of Butlerville Road Bridge over Croton River (BIN 3348590), Town of Somers, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Arben Group LLC, submitted the low bid in the amount of \$3,288,617.00.

The low bidder has been investigated and it has been found that Arben Group LLC:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to repair substandard structural elements of the Butlerville Road Bridge.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Butlerville Road Bridge meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 15-526 be awarded to Arben Group LLC in the amount of \$3,288,617.00.
