On February 2, 2022 the County of Westchester ("County") received and opened ten (10) bids for Contract No. 15-550 for Woodlands Lake Dam Rehabilitation, V.E. Macy Park, Irvington, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Papitto Construction Co., Inc. submitted the low bid in the amount of \$4,900,000.00.

The low bidder has been investigated and it has been found that Papitto Construction Co., Inc.:

- Performed satisfactory work in the past for the County.  
 Past experience has been investigated and found satisfactory.

The objective of this contract is to improve the infrastructure of the Woodlands Lake Dam.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that the Woodlands Lake Dam meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 15-550 be awarded to Papitto Construction Co., Inc. in the amount of \$4,900,000.00.
