On March 16, 2022 the County of Westchester ("County") received and opened four (4) bids for Contract No. 20-510 for Rehabilitation of Farragut Avenue, C.R. #151, from the Fenway to Broadway, a Total Distance of Approximately 0.74 Miles, Village of Hastings-on-Hudson, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Westchester Hills Landscaping, Inc. submitted the low bid in the amount of \$1,290,144.00.

The low bidder has been investigated and it has been found that Westchester Hills Landscaping, Inc.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving and to repair the substandard structural elements of Farragut Avenue.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Farragut Avenue meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 20-510 be awarded to Westchester Hills Landscaping, Inc. in the amount of \$1,290,144.00.
