Re: **Resolution Authorizing the County of Westchester to enter into a Film Permit with Universal Television, LLC to authorize filming at Westchester Community College from March 11, 2022 through March 21, 2022 an estimated permit fee of \$47,725.**

Authority is requested for the County of Westchester (“County”), acting by and through its Office of Tourism & Film, to enter into a film permit (the “Film Permit”) with Universal Television, LLC to utilize locations at the Westchester Community College, Valhalla, New York, to film the television series “FBI: Most Wanted” from March 11, 2022 through March 21, 2022. This request is being made because the Film Permit, which authorizes an estimated fee of \$47,725 to be paid to the County, which includes estimated overtime costs for County personnel, requires your Honorable Board’s approval. The Film Permit will result revenue for the County and will also promote the County and provide revenue for local businesses.

This agreement will serve a public purpose by encouraging film production in Westchester County and will result in local economic development as well. The goal of providing Westchester County locations for films and commercial photography will be monitored by the Westchester County Office of Tourism & Film. Your Honorable Board’s approval of this Film Permit will increase film permit revenues to the County.

For all the foregoing reasons, a resolution authorizing a Film Permit with NBC Universal Media, LLC, is attached for your Honorable Board’s approval.
