RESOLUTION AUTHORIZING THE COUNTY OF WESTCHESTER TO ENTER INTO AN AGREEMENT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES, IN AN AMOUNT NOT TO EXCEED \$14,630 IN GRANT FUNDS, FOR THE DISTRICT ATTORNEY'S OFFICE TO OPERATE A CRIME MAPPING SOFTWARE PURCHASE GRANT FROM JANUARY 1, 2010 TO DECEMBER 31, 2010, PURSUANT TO AN APPROVED BUDGET.

Authority is sought for the County of Westchester to enter into an agreement with the New York State Division of Criminal Justice Services (DCJS), in an amount not to exceed \$14,630 for the District Attorney's Office to operate a Crime Mapping Software Purchase Grant from January 1, 2010 to December 31, 2010, pursuant to an approved budget. There is no County Cash match for this program.

Through this grant, the District Attorney's office will purchase two (2) software licenses for ArcInfo crime mapping software. This program will promote the general welfare and safety of the citizens of Westchester County as the software will enable Westchester law enforcement to take new sets of data and utilize current geocoded mapping data to produce interactive maps to assist police agencies in the County in developing strategies that will abate crime. The goals and objectives of the program are monitored by the District Attorney's Office and quarterly reports are submitted to DCJS for their review and approval.

The requirements of the Westchester County Procurement Policy were followed. The Procurement is exempt under Section 3(a) iii, which provides for the exception "Transactions/contracts with the United States of America, any state, agency...". The agreement is a transaction/contract with the New York State Division of Criminal Justice Services.

Wherefore, authority is respectfully sought for the County to enter into this agreement.

RESOLUTION

Upon communication from Janet DiFiore, District Attorney, be it hereby,

RESOLVED, that the County of Westchester is authorized to enter into an agreement with the New York State Division of Criminal Justice Services in the amount not to exceed \$14,630 in Grant Funds pursuant to an approved budget; and be it further,

RESOLVED, that the District Attorney or her duly authorized designee is hereby empowered to execute any and all documents necessary to accomplish the purposes of this resolution.
