On July 27, 2022, the County of Westchester ("County") received and opened one (1) bid for Contract No. DSS6051-22 for transportation services for youth in foster care and youth in court-directed custody.

The bid was reviewed by the Department of Social Services ("DSS") and it was determined that All County Bus, LLC submitted the low bid, in the amount of \$2,250,000.00 for the initial term of one (1) year, commencing on September 1, 2022 and continuing through August 31, 2023, with the County having four (4) additional one (1) year options thereafter, with such options, if exercised, to be paid on the cost terms specified in the bid solicitation.

The low bidder has been investigated and it has been found that All County Bus, LLC:

- Performed satisfactory work in the past for the County.
- Past experience has been investigated and found satisfactory.

**CONTRACT NO. DSS6051-22**

Upon a communication from the Commissioner of Social Services, be it hereby:

**RESOLVED**, that Contract No. DSS6051-22, for transportation services for youth in foster care and youth in court-directed custody, be and is hereby awarded by the County of Westchester ("County") to the low bidder, All County Bus, LLC, in the amount of \$2,250,000.00 for the initial term of one (1) year, commencing on September 1, 2022 and continuing through August 31, 2023, with the County having four (4) additional one (1) year options thereafter, with such options, if exercised, to be paid on the cost terms specified in the bid solicitation; and be it further

**RESOLVED**, that this contract is subject to County appropriations; and be it further

**RESOLVED**, that this contract is also subject to further financial analysis of the impact of any New York State Budget (the "State Budget") proposed and adopted during the term of this contract. The County shall retain the right, upon the occurrence of any release by the Governor of a proposed State Budget and/or the adoption of a State Budget or any amendments thereto, and for a reasonable period of time after such release(s) or adoption(s), to conduct an analysis of the impacts of any such State Budget on County finances. After such analysis, the County shall retain the right to either terminate this contract or to renegotiate the amounts and rates approved herein. If the County subsequently offers to pay a reduced amount to the contractor, then the contractor shall have the right to terminate this contract upon reasonable prior written notice; and be it further

**RESOLVED**, that the County Executive or his duly authorized designee is hereby authorized to execute any documents and take any actions reasonably necessary and appropriate to effectuate the purposes of this resolution.
