On July 27, 2022, the County of Westchester ("County") received and opened eight (8) bids for Contract No. 17-540 for Rehabilitation of Commerce Street, C.R. No. 29, from Stevens Avenue to Liberty Street, a Distance of 1.23 Miles, Mount Pleasant, New York.

The bids were reviewed by the Department of Public Works and Transportation ("Department") and it was determined that Gianfia Corp. submitted the low bid in the amount of \$4,133,962.50.

The low bidder has been investigated and it has been found that Gianfia Corp.:

- Performed satisfactory work in the past for the County.
 Past experience has been investigated and found satisfactory.

The objective of this contract is to replace substandard areas of asphalt paving and to repair the substandard structural elements of Commerce Street.

This contract is in the public's best interest because it will promote the health and safety of the general public by ensuring that Commerce Street meets current codes and standards as well as reducing the County's annual maintenance costs.

The Department will track scheduling and accomplishments by the contractor and perform on-site inspections to ensure the successful completion of this project.

It is my recommendation that Contract No. 17-540 be awarded to Gianfia Corp. in the amount of \$4,133,962.50.
